- 2. Natural Internal Elements: Cereals, pasta, and natural seeds. Origin: Spain.
- 3. Decorative Miniatures: Non-toxic plastic figures. Origin: Germany and China.
- 4. Other Internal Materials of Our Products:
- Glitter: Origin Germany and China.
- Wool pom-poms. Origin: China.

- Liquid: Safe blend of purified water, preservatives, and non-toxic natural colorants. Manufactured in Spain.

- Medical-grade non-toxic oil and natural beech wood for Sensory Stars, Sensory Moon, and Move Bottles. Manufactured in China, designed, and assembled in Spain.

- Sensory Balls: Made from cotton, wool, cork, metal, and wood. Manufactured in Spain, Germany, and New Zealand, assembled in Spain.

- Palm Basket: Manufactured in Spain with natural palm leaves.

- For toy hygiene, clean with a wet wipe or damp cloth.

- Do not submerge the toy in water or expose it to prolonged sunlight or high

temperatures

to avoid damage.

- Spy Forest Model: Natural cereals and seeds, miniature forest animals (hedgehog, deer, owl...).

- Jungle Model: Natural cereals and seeds, miniature elephant, giraffe, lion...

- Float Bottle Model: Sensory formula, glitter, sequins, and wool pom-poms.
